The Health Care Agency (HCA) invites tenders for the Provision of Maintenance Services at Health Care Facilities

SOURCE OF FINANCE: Health Care Agency

ELIGIBILITY:

The following are eligible to tender on equal terms. Contractors Class 2 and 3 ONLY registered and licensed to operate in Seychelles.

Conditions:

- i. Bidders must demonstrate previous experience in facility maintenance or similar projects within the last Three (3) years.
Bidders must have qualified technical staff and necessary equipment to perform the services
- ii. Bidders must comply with all relevant Seychelles laws, regulations, and Ministry of Health standards related to construction, maintenance, safety, and environmental protection.
- iii. Tender is divided into Four (4) Lots and bidders are eligible to bid for one or all lots
- iv. Only one Lot will be awarded per bidder

PLACE OF PERFORMANCE: Anse Royale Hospital, Wellness Centre Les Canelles, Family Hospital, Ile Perseverance, Baie Ste Anne Praslin Hospital & Grand Anse Praslin Clinic
