ELIGIBILITY: The following are eligible to tender on equal terms: **Contractors Class 1** registered and licensed to operate in Seychelles.

PLACE OF PERFORMANCE: FISHING PORT, VICTORIA

PERFORMANCE PERIOD: 8 Calendar Weeks

ACCESS TO TENDER DOSSIER: The tender Dossiers can be obtained from Seychelles Ports Authority (SPA) at the Procurement Office, Latanier Road, Mahe as **from Monday 13th July 2026 0830hrs to 1430hrs** upon payment of a non-refundable fee of **SR 150.00 each** and deadline date for obtaining the dossier shall be **Friday 17th July, 2026 not later than 1430hrs.**

Potential Bidders shall provide a copy of the **valid Class 1 license**, upon purchase of the tender dossier. Potential Bidder shall be allowed to inspect the tender dossier prior to purchase.

PRE-BID MEETING / SITE VISIT: A mandatory site information meeting/site visit has been organized on **Tuesday 21st July 2026 at 1030hrs.** The meeting point shall be at the Fishing Port, Victoria.

Failure to attend the site information meeting/site visit will result in the disqualification of the bidder.
