



INVITATION TO TENDER

The Fair Trading Commission (“FTC”) invites tenders for the **Procurement of One (1) Sport Utility Vehicle (SUV).**

- Source of finance:** Government of Seychelles
- Eligibility:** The following are eligible to tender on equal terms. All licensed Motor Vehicle dealers operating in Seychelles.
- Subject:** Vehicle is to be used for administrative duties, staff transportation for official engagements; inspections, site-visits and compliance activities.
- Period of Delivery:** Three (3) Months from the date of the award of contract.
