



INVITATION TO TENDER

The Seychelles Public Transport Corporation ("SPTC") invites tenders for the **Procurement of Vehicles.**

The tender is divided into Two (2) lots as follows:

1. Lot 1 – One (1) Pick-up Truck
2. Lot 2 – Two (2) Smart Hybrid Vehicle

Bidders may participate in one (1) or both lots. And Bidders will be eligible to be awarded with one (1) lot or both lots.

Source of finance: GOS.

Eligibility: The following are eligible to tender on equal terms. All licensed Motor Vehicle dealers operating in Seychelles.

Subject: Vehicles are to be used for administrative duties and Maintenance and infrastructure team.

Period of Delivery: Four (4) Months from the date of the award of contract.
