<u>Source Of Finance:</u>	Seychelles Airports Authority
<u>Eligibility:</u>	The following are eligible to tender on equal terms. All contractors Class I and II only registered and licensed to operate in Seychelles.
<u>Place of Performance:</u>	Seychelles International Airport
<u>Performance Period:</u>	Twelve (12) weeks from Award of Contract
<u>Access to Tender Dossier:</u>	The Tender Dossiers can be obtained from the Procurement Section, Seychelles Airports Authority at Sunshine House, First Floor, Providence, Mahe as of <u>Thursday 5th February 2026 between 9:00am to 3:00pm</u> against payment of a non-refundable fee of <u>SCR 300 each</u> .
<u>Closing Date for Dossier:</u>	The closing date for obtaining the tender dossier is <u>Wednesday 11th February 2026 at 3:00pm</u> . No Tender Dossier will be available after the closing date.
<u>Pre-Tender Site Visit:</u>	A mandatory site visit / information meeting has been organized on <u>Friday 13th February 2026 at 10:00am</u> . The meeting place shall be at the Cargo Terminal Gate 3 at the Seychelles International Airport . Failure to attend the site information meeting / visit shall lead to bids being disqualified during the Evaluation Stage.

Potential Bidders shall provide a copy of the **valid license, Business Registration Number and NIN** upon purchase of the tender dossier and shall be allowed to inspect the tender dossier prior to purchase.
