

INVITATION TO TENDER

- Source of Finance:** The Public Utilities Corporation (PUC)
- Project Title:** **WATER PIPELAYING WORKS FROM ANSE ROYALE TO SANTA MARIA**
- Eligibility:** All Locally Registered Contractors with a valid **Class One (1)** license operating in Seychelles.
- Subject:** PUC intends to undertake water pipelaying works from Anse to the existing PUC water tank at Santa Maria. The works shall comprise of the following main works:
1. Site Clearance
 2. Excavation and backfilling works
 3. Pipelaying works (225mm HDPE water pipe)
 4. Cutting of asphalt
 5. Reinstatement works
 6. Construction of manholes, corbels, pillars etc.
- Project duration is **7 months**
