- Source of Finance:** The Public Utilities Corporation (PUC)
- Project Title:** **Centralized sewerage extension at Military Training Centre - Perseverance**
- Eligibility:** All Locally Registered Contractors with a valid **Class One (1)** license operating in Seychelles.
- Subject:** PUC intends to undertake an extension of its sewerage network in the Perseverance area, in the Military training centre compound. The Works shall comprise of the following:
1. Excavation and backfilling works
 2. Pipelaying
 3. Concrete/asphalt cutting
 4. Reinstatement works
 5. Reinforced concrete works: for manholes, foundation for prefab sewerage pumps etc.
