

INVITATION TO TENDER

- Source of Finance:** The Public Utilities Corporation (PUC)
- Project Title:** **WASTEWATER NETWORK EXTENSION AT PLAISANCE (LO LANMAR) PHASE 1**
- Eligibility:** All Locally Registered Contractors with a valid **Class One (1)** license operating in Seychelles.
- Subject:** PUC intends to undertake wastewater network extension works at Plaisance Lo Lanmar. The works shall comprise of the following:
1. Site clearance
 2. Marking of pipeline routes
 3. Excavation and trenching works
 4. Installation of pipes with appropriate gradient
 5. Installation of pressure lines
 6. Reclamation works
 7. Reinstatement of all disturbed surfaces including landscaping, driveways and pavements
