- Source of Finance:** The Public Utilities Corporation (PUC)
- Project Title:** **FENCING OF PUC COMPOUND ON EVE ISLAND - PRASLIN**
- Eligibility:** All Locally Registered Contractors with a valid **Class One (1)** license operating in Seychelles.
- Subject:** PUC intends to undertake fencing works to secure its property on Eve Island Praslin. The works shall comprise of the following:
1. Site clearance
 2. Removal of existing fence & carting away
 3. Excavation and backfilling works
 4. Concrete works
 5. Supply and install of palisade fencing
