INVITATION TO TENDER

The Seychelles Ports Authority invites tenders for “*Maintenance Dredging at Eve Island, Praslin*”. The aim of the tender is to remove sedimentation/debris at the seabed to increase the depth of the channel and berth area to ensure a safe passage for water transport.

Project Title : Maintenance Dredging at Eve Island, Praslin

Reference Number : PRJ/014/22

Eligibility : All licensed and registered contractors with Class 1 only operating in Seychelles are eligible to tender on equal terms.

Period of Delivery : Two (2) months from the notice to commence.

Access to Tender Dossier : The Tender Dossier can be obtained from the Procurement Section Office, Seychelles Ports Authority, Mahe Quay, New Port, Mahe, Seychelles as from **9.00am to 2.00pm Monday 09th May, 2022 to Friday 13th May, 2022.**

NOTE: *The tender dossier is available at a non- refundable fee of SCR 500.00 to all interested bidder.* Bidders may inspect the bidding document prior to purchase.

Ensure a valid Class 1 license is produced upon purchasing of tender documents

Bidders are welcome to attend a mandatory pre-tender meeting/site visit scheduled for **Tuesday 17 May, 2022 at 1000hrs.** The meeting point is SPA Eve Island Annex Passenger Shelter.

Bidders failing to attend the pre- tender meeting/ site visit will be disqualified during the Evaluation Stages.

Submission of Tender Dossier:

TENDERS MUST BE SUBMITTED IN A SEALED ENVELOPE MARKED “MAINTENANCE DREDGING AT EVE ISLAND, PRASLIN”, ADDRESSED TO THE CHIEF EXECUTIVE OFFICER OF THE NATIONAL TENDER BOARD(NTB) SECRETARIAT AND DEPOSITED IN THE TENDER BOX AT THE NATIONAL TENDER BOARD (NTB) SECRETARIAT, 1ST FLOOR, MAISON DE MAHE, VICTORIA NOT LATER THAN 1030HRS (SEYCHELLES TIME) ON WEDNESDAY 15TH JUNE, 2022.

THE TENDER SHALL BE SINGLE -STAGE-TWO ENVELOPE METHOD, WHICH A BID IS SUBMITTED IN AN OUTER SEALED ENVELOPE, CONTAINING TWO SEPERATELY SEALED AND LABELED TECHNICAL AND FINANCIAL BIDS WHICH ARE NOT OPENED ON SAME DATE.

ANY BIDS RECEIVED AFTER THE DEADLINE WILL NOT BE ACCEPTED AND WILL BE RETURNED UNOPENED TO THE BIDDER.
