SOURCE OF FINANCE: Government of Seychelles

ELIGIBILITY: The following are eligible to tender on equal terms. All **Contractors Class I only** registered and licensed to operate in Seychelles.

For those bidders having an existing civil work contract with the SLTA, for which those contracts are less than 75% completed, will not be eligible to participate in this tender.

PLACE OF PERFORMANCE: Road Junction near SITE and Forêt Noire Road, Mont Fleuri

PERFORMANCE PERIOD: 6 months

ACCESS TO TENDER DOSSIER: The tender Dossiers can be obtained from the SLTA's Accounts Office at Dreamgate complex, Block B, 1st Floor, Ile Du Port as of **Friday 10th June 2022 from 9:00 am to 12.00am and 1.00pm to 3.00 pm** upon payment of a non-refundable fee of **SR 150.00 each**. The deadline date for obtaining the dossier shall be **Monday 20th June 2022 not later than 3.00pm**.

Potential Bidders shall provide a copy of the valid license upon purchase of the tender dossier and shall be allowed to inspect the tender dossier prior to purchase.

SITE VISIT: A mandatory site information meeting/site visit has been organized on **Tuesday 21st June 2022 at 10:00 am** and the meeting place will be at the Parking Area next to the Mont Fleuri playing field on Foret Noire road. Failure to attend the site information meeting /site visit will result in the disqualification of the bidder during the Evaluation process.
