The Seychelles Fishing Authority is inviting licensed and registered Companies to tender for **THE PROVISION OF PEST CONTROL SERVICES** on its premises on Mahé, Praslin, and La Digue.

Conditions

- The tender is opened for all locally registered and Licensed PEST Control Operators in Seychelles.
- All pricing should be in Seychelles Rupees (SR)
- Contract Duration - One (1) Year
- Provide proof of verifiable previous experiences of similar work within the last (5) years
