ELIGIBILITY: The following are eligible to tender on equal terms. All **Contractors Class 1** registered and licensed to operate in Seychelles.

PLACE OF PERFORMANCE: Anse Gaulette- Baie Lazare

PERFORMANCE PERIOD: 16 calendar weeks
