

INVITATION TO TENDER

- Source of Finance:** The Public Utilities Corporation (PUC)
- Project Title:** **Demolition and Re-construction of a Pump House at Creve Coeur – Beau Vallon**
- Eligibility:** All Registered Contractors with a valid **Class I** license for such work.
- Subject:** The existing PUC pump house at Creve Coeur needs to be demolished and reconstructed as soon as possible. PUC intends to reconstruct this pump house and realign the accompanying pipeline. The Works shall comprise of the following:
1. Demolition works and carting away
 2. Excavation Works
 3. Backfilling and Compaction works
 4. Reinforced concrete works (foundation, beam, etc.)
 5. Roofing works
 6. Electrical works
 7. Pipeline replacement
- Collection of tender:** Tender dossier can be obtained from the **PUC's Procurement Office, Maison de Malavois, Bois de Rose Avenue** against payment of a non-refundable fee of **SCR 500.00** each as from **Tuesday 13th September 2022** to **Tuesday 20th September 2022** from **08:00hrs** to **12:00hrs**. All interested Bidders should provide a copy of their valid license and are allowed to inspect the document before purchasing the document.
- Pre-Bid meeting:** A pre-bid meeting has been scheduled to take place on **Friday 23rd September 2022** at **10:00hrs** at **Conference Room, PUC Office, Electricity House, Roche Caiman**.
Followed by:
- Site-Visit:** A site visit will be held on the project site starting at **Creve Coeur** on **Friday 23rd September 2022** after the pre-bid meeting.

Please note that it is mandatory for all interested bidders to attend the pre-bid meeting and site visit. Bidders failing to attend the pre-bid meeting and the site visit will be disqualified in the evaluation process.
