- Project Title:** **Tender for the Hiring of boats and divers for collection of sea water samples**
- Eligibility:** Fully licenced boat owners and divers.
- Subject:** PUC is seeking for the services of licensed boat owners and qualified divers for collection of water samples at different Intake and Discharge Points of the Desalination Plants and Sewage outfalls on Mahé and La Digue. This form part of our continuous effort of minimizing the environmental impact of waste discharges and in compliance with EMS 14001:2015 and PUC Environments Policy.

- Lot 1: - Intake and discharge point of existing reverse osmosis plants: Providence, Bel Ombre and Perseverance on a monthly basis at varying depths.
New proposed point discharge sites: Anse Boileau and Providence on a quarterly basis at varying depths.
Control Point and Sewage outfalls: Anse Aux Pins, Providence, Beau Vallon, Bel Ombre and Pointe Larue twice yearly at varying depths.
- Lot 2: - Collecting sea water samples at varying depths at new proposed point of Discharge for La Digue Desalination Plant.
