### INVITATION TO TENDER

The Seychelles Ports Authority invites tenders for “*Renovation on Existing Facilities at the Operation Yard Mahe Quay*”. The aim of the tender is to improve the Operation staffs working environment.

**Project Title** : Renovation on Existing Facilities at the Operation Yard, Mahe Quay.

**Reference Number** : PRJ/009/22

**Eligibility** : All licensed and registered contractors with Class 2 only operating in Seychelles are eligible to tender on equal terms.

**Period of Delivery** : 90 days from the notice to commence.
