INVITATION TO TENDER

The Seychelles Revenue Commission invites tenders for the Procurement of One (1) Bus and One (1) Car.

The Procurement of Vehicles is divided into Lot of Two (2) as follows:

- Lot 1 - One (1) fifteen seater Bus
- Lot 2 - One (1) Seven seater Car

- i. Bidders may participate in one (1) or both lots.
- ii. Bidders will be eligible to be awarded with one (1) lot or both lots.

Project Title : Procurement of Vehicle (One (1) Bus) and 1 One (1) Car

Eligibility : All licensed and registered Motor Vehicle dealers operating in Seychelles are eligible to tender on equal terms.
