<u>ELIGIBILITY:</u> The following are eligible to tender on equal terms. All **Contractors CLASS 1 & 2 ONLY** registered and licensed to operate in Seychelles.

PLACE OF PERFORMANCE: La Plaine Hollandaise, Grand Anse Praslin.

PERFORMANCE PERIOD: 120 working days

ACCESS TO TENDER DOSSIER: The tender Dossiers can be obtained on Praslin from the SLTA's Office, Amitie, Grand Anse Praslin as of Wednesday 24th May, 2023 from 08:30 am to 12:00 pm and 1.00pm to 3.00pm upon payment of a non-refundable fee of SR200.00 each and deadline date for obtaining the dossier shall be Wednesday 31st May, 2023 not later than 3:00 pm.
