ELIGIBILITY: The following are eligible to tender on equal terms. All Contractors Class 2 and 3 Registered, Licensed and based on La Digue ONLY.

SUBJECT: The project entails construction of a weighbridge concrete and comprises of the following:

1. Excavation works
2. Backfilling works
3. Construction works inclusive of Concreting and Structure
4. Steel works inclusive of Reinforcements
5. Installation and supply ducting/ wire to control room

PLACE OF PERFORMANCE: La Digue Landfill – L'Union Estate
