ELIGIBILITY: The following are eligible to tender under equal terms. Building Contractors with **CLASS II and III** Certificate ONLY, having a valid license registered in Seychelles address on La Digue.

PLACE OF PERFORMANCE: La Passe, La Digue

PERFORMANCE PERIOD: 1 month

ACCESS TO TENDER DOSSIER: The Tender Dossiers can be obtained on La Digue from the DA's Office, La Passe as of **Tuesday 02nd November 2021 from 08:00 am to 2:00 pm** upon payment of a non-refundable fee of **SR150.00 each**. The deadline for obtaining the dossier shall be **Monday 08th November, 2021 not later than 2:00 pm**.

Potential Bidders shall provide a copy of the valid license upon purchase of the tender dossier. Potential bidders shall be allowed to inspect the tender dossier prior to purchase.
