The Seychelles Public Transport Corporation invites tenders for the Procurement of Radial-Ply Tyres

Division in Lots : The tender is divided into Two (2) Lots;

LOT 1	LOT 2
11R22.5 (Tubeless)	900R20 (Tube and Flap)

Bidders are eligible to participate in One (1) or all lots and will be eligible to be awarded with one or both lots.

Eligibility : The following are eligible to tender on equal terms. **All licensed, registered and/or authorized agent dealers or distributors of tires operating in Seychelles.**

Period of Delivery : **CIF; SPTC Warehouse, Providence, Mahe, Seychelles**
In four to six consignments, shipped in 40ft containers of not less than 240 tyres per container
First Shipment, 1 40ft container, ETA Seychelles 12 weeks from the date of contract award
Balance shipment to be confirmed by SPTC upon copy Bill of Lading of previous Shipment
