INVITATION TO TENDER

The Seychelles Ports Authority invites tenders for “*Maintenance Work on the Existing Warehouse at Eve Island Cargo Praslin*”. The aim of the tender is to improve the storage area used for stacking of cargoes at Eve Island.

- Project Title** : Maintenance Work on the Existing Warehouse at Eve Island Cargo - Praslin.
- Reference Number** : PRJ/041/20
- Eligibility** : All licensed and registered contractor Class 2 only operating in Seychelles are eligible to tender on equal terms.
- Period of Delivery** : Twenty (20) working days from the notice to commence.
- Access to Tender Dossier** : The Tender Dossier can be obtained from the Procurement Office, New Port, Mahe Quay and Head Pier Masters office on Praslin, Seychelles as from **9.00am to 3.00pm on Monday 10 January, 2022 to Friday 14 January, 2022.**
